

## CONDITIONS FOR USING EXTREME SPORTS CENTRE SPOT

1. These conditions for using Extreme Sports Centre Spot (hereinafter: Spot) (hereinafter: Conditions) shall determine the rights, obligations and liability of the administrator of Spot, Elamusspordikeskus Ühing MTÜ (registry code: 80313138) and the visitor of Spot (hereinafter: Customer) upon the use of attractions (hereinafter: Areas) by the Customer.

2. The Conditions shall apply to all Customers who enter the Areas of Spot.

3. The Customer is aware that the use of Spot may damage the Customer's clothes and the items taken with, and may be dangerous for the Customer's life and health. In order to avoid the danger, the Customer undertakes to follow strictly all instructions given by the employees of Spot, the safety and security requirements and the requirements set out in the Conditions (hereinafter jointly: Requirements). The use of the Spot Areas shall take place at the Customer's risk (liability) and Elamusspordikeskus Ühing MTÜ is not liable for any possible damage caused to the Customer (including damage to health and property).

4. The Customer is aware that if the Customer books an employee of Spot for giving instructions on the Areas, the employee of Spot has only an instructive role, wherefore in this case the use of the Spot Areas shall also take place at the Customer's risk (liability).

5. The Customer is not allowed to use the Area before he/she has received necessary instructions from the employee of Spot and the Customer wears required safety equipment. The Customer can use personal safety equipment or rent it for a fee from Sport. The safety equipment rented from Spot is allowed to use only personally and safety equipment shall be returned to the employee of Spot/receptionist after the use. If the Customer prefers to use personal safety equipment, Spot is not liable for compliance of the Customer's safety equipment with the requirements.

6. The Customer undertakes to be attentive while moving on the Spot Areas and between the Areas, to follow all Requirements and Conditions, additional instructions/orders of the Spot employees and the signs, directions and symbols located on the Areas. **Any non-compliance with the Requirements and stay on the Area without proper safety equipment is dangerous to life!**

7. Before using the Area, the Customer is required to make sure that the chosen Area corresponds to his/her physical abilities, health conditions and skills, and give up using the Area if it does not correspond to the aforementioned circumstances. If the Customer begins to feel worse and the use of the Area or staying on the Area is therefore no longer safe, the Customer is required to immediately leave the Area. If the Customer feels for any reason that the use of the Area is no longer safe, the Customer is obligated to address promptly the Spot instructor/employee in order to receive additional instructions for safe use of the Area, or confirmation that it is safe to use the Area.

8. It is prohibited to be in Spot in a state of intoxication caused by the use of alcohol, narcotic or psychotropic substance, and to use the within-named substances or to smoke.

9. The employee of Spot has the right not to allow the person whose conditions or abilities do not enable in the opinion of the employee of Spot safe use of the Areas to use the Areas. The

employee of Spot has the right to immediately call the Customer off the Area if the Customer violates the Requirements or the Conditions, does not follow the orders given by the employee of Spot or if it is no longer safe to stay on the Area or use the Area in the opinion of the employee of Spot.

10. If the Customer notices any shortcomings in the working condition of the Areas and safety equipment, he/she shall promptly notify thereof the employee of Spot.

11. The Customer shall pay for using the Areas of Spot according to the price list which is effective in Spot. Upon entry into Spot, the Customer will be given a wristband which he/she shall wear during the entire time of using Spot and it has to be visible. The Customers have the right to use the Areas of Spot and stay on them until the agreed usage period expires. Upon exceeding the agreed usage period, the Customer shall pay additionally according to the price list.

12. It is allowed to consume only locally purchased food and drinks in Spot.

13. The Customer is required to use the Areas of Spot and safety equipment carefully and not break them or damage in any other manner, and compensate to Elamusspordikeskus Ühing MTÜ for all damage that has been caused by damaging the Areas and/or the safety equipment due to the Customer's negligent or intentional behaviour.

14. The Customer shall take into consideration that Spot will not guarantee the Customer's safety or be liable for the damage caused by damages to the Customer's health or the Customer's death.

15. Spot is not responsible for any damage caused by damage to, loss of or destruction of the Customer's clothes and other items.

16. Leaving the vehicle in the car park near Spot shall not be deemed to be entry into a deposit contract of a vehicle and Spot is not responsible for the destruction, loss of (including theft) or damage to the vehicles left in the car park and the items therein.

17. The fee paid for using Spot shall be refunded to the Customer only if the use of Spot proves impossible due to the circumstance dependent on Spot. In other cases, including when the Customer gives up the use of Spot and in the case referred to in clause 9, the fee paid by the Customer shall not be refunded.

18. The Customer confirms by his/her signature that he/she has been informed of the fact that what happens on the Areas may be filmed in Spot and what has been filmed may be disclosed, and that (fixed) cameras may be situated in conspicuous positions in Spot. The Customer is prohibited from photographing and filming other persons without their previous consent, or from disclosing, copying and processing the photographed and filmed works.

**19. A parent confirms with his/her signature that he/she has read through the Conditions for using the Extreme Sports Park, is aware of the nature of the Extreme Sports Park, takes into consideration the dangers related to the use thereof by the minor and grants his/her consent that his/her son/daughter shall use the Extreme Sports Park without an adult person's supervision.**

## Rules of Extreme Sports Centre Spot

### General rules:

1. By purchasing the ticket you confirm that you agree to the rules of Extreme Sports Centre Spot.
2. Extreme Sports Centre Spot is used on one's own responsibility!
3. All visitors of the Centre have to examine the rules and confirm by their signature that they have examined the rules.
4. A person under 18 years of age must bring along a written permission from his/her parent.
5. Persons who are in a state of alcohol or drug intoxication are prohibited on the territory!
6. Enter the hall with clean exercise equipment.
7. Take into consideration other users of the Centre.
8. Use only indoor footwear in the building.
9. Leave all excessive items in the locker. It is recommended to leave the valuables in the safe deposit box at the receptionist's.
10. Extreme Sports Centre Spot is not responsible for the items in the lockers.
11. When using the Centre, follow the instructor's signals.
12. Always wear a wristband!
13. Broken wristband will be replaced only when you show the broken wristband!
14. Cycling on passageways is not allowed!
15. Let's keep the places clean!
16. Wall scribbling and sticking one's stickers in the building is strictly forbidden!
17. Do not damage or ravage the trees, bushes, flowers, etc. on the territory.
18. While being in the Centre, always throw the trash in a trash can.
19. Keep the food or drink in the area designated for that purpose (café, the 2<sup>nd</sup> and 3<sup>rd</sup> floor balconies)! Only water is allowed in the exercise area.
20. Going into the café with a vehicle is forbidden.
21. Smoking is only allowed in designated smoking areas.
22. If you want to watch the cycling, you can do it on the 2<sup>nd</sup> and 3<sup>rd</sup> floor balconies.
23. It is prohibited to bring pets into the premises of Extreme Sports Centre Spot.
24. Visitors must inform when the inventory of the Centre has been damaged.
25. Visitors of Extreme Sports Centre Spot are required to immediately inform the employees of the park of any accidents or other incidents.
26. The employees of Extreme Sports Centre Spot are entitled to change the rules according to the situation.
27. The instructor's instructions are not debatable. Permanent trouble-makers may be removed from the hall!

### Pump Track

1. Before entering the track, make sure that the vehicle is technically sound.
2. Follow the instructor's orders.
3. Always wear a helmet.
4. The helmet chin strap has to be properly attached!
5. Knee and elbow pads and shin guards are recommended.
6. Do not cycle outside the lane.
7. Stay in your lane and do not cycle across the lane.
8. Pegs on bikes are not allowed.
9. Behave prudently and respect and watch other bikers.
10. Overtaking is prohibited!

### Street Course

1. Before entering the track, make sure that the vehicle is technically sound.
2. Follow the instructor's orders.
3. Always wear a helmet, except for skateboarders who are older than 18 years for whom the helmet is recommended.
4. The helmet chin strap has to be properly attached!
5. Knee and elbow pads and shin guards are recommended.
6. Behave prudently and respect and watch other bikers.
7. Observe very carefully other bikers' tracks, especially in the places where they may be out of your visual field!
8. Only plastic pegs allowed

### Super Bowl

1. Before entering the track, make sure that the vehicle is technically sound.
2. Follow the instructor's orders.
3. Always wear a helmet.
4. The helmet chin strap has to be properly attached!
5. Knee and elbow pads and shin guards are recommended.

6. Behave prudently and respect and watch other bikers.
7. Observe very carefully other bikers' tracks, especially in the places where they remain outside of your visual field!
8. Always signal others when you start to move.
9. Observe carefully the persons entering the park, especially if they remain outside of your visual field.
10. Only plastic pegs allowed

### BMX Racing Track

1. Before entering the track, make sure that the vehicle is technically sound.
2. Follow the instructor's orders.
3. Always wear a helmet.
4. The helmet chin strap has to be properly attached!
5. Knee and elbow pads and shin guards are recommended.
6. Do not cycle outside the lane.
7. Stay in your lane and do not cycle across the lane.
8. Pegs on bikes are not allowed.
9. Behave prudently and respect and watch other bikers.

### Launch pad (drop-in and resi)

1. Before entering the area, make sure that the vehicle is technically sound.
2. Before using the area, you have to pass the corresponding introductory course!
3. Before jumping into the foam rubber box, make always sure that your pockets are empty from your personal belongings!
4. Follow the instructor's orders, the use of the area is not allowed without the instructor being present!
5. Movement on the area is organized by the instructor!
6. Before lowering yourself down to drop-in, wait for the instructor's signal.
7. Always wear a helmet.
8. The helmet chin strap has to be properly attached!
9. Knee and elbow pads and shin guards are recommended.
10. Upon preparing for resi jump on the drop-in mountain, make always sure that the previous biker has left the resi landing!
11. Stay in your lane and do not cycle across the lane.
12. We will leave the foam rubber cubes into the foam rubber box and we will not take them out of the box!
13. Behave prudently and respect and watch other bikers.
14. No pegs allowed

### Acrobatics area

1. Communication is vital! Make sure that other users understand your intentions - whether you jump from one trampoline on another or into the foam rubber box!
2. If you just want to watch, stand outside the trampoline and spring floor area!
3. Trousers with rivets and zips are prohibited.
4. In the acrobatics area we move only wearing gymnastics shoes or socks!
5. Only one user at a time may jump on the trampoline! The only exception being the employees of Extreme Sports Centre Spot!
6. Before jumping into the foam rubber box, make always sure that your pockets are empty from your personal belongings!
7. Jumping from the wall next to the super trampoline shall take place only following the instructor's instructions.
8. Trampoline belts are used only under the instructor's supervision.
9. The gym hall has to look the same when you leave, i.e. always put the equipment back in its proper place!
10. We will always observe the movement of others on the acrobatics floor. If there are more people on the floor, always make sure when you intend to jump that everything is safe!
11. We will go on the trampoline alone. No impetus may be given on the trampoline!
12. When jumping into the foam rubber box, make always sure that no-one else is jumping into it at the same time and coordinate your movements with each other!
13. When jumping into the foam rubber box, make also sure that no-one else is already in the box!
14. While learning new elements, always ask for the instructor's advice in order to avoid the risk of injuries and for the elements to succeed better!
15. On the super trampoline make always sure that no-one is about to jump simultaneously into the foam rubber box!
16. We will leave the foam rubber cubes into the foam rubber box and we will not take them out of the box!
17. We will use the mats for their intended purpose!
18. Let's keep the gym hall in order and mind the people!
